- 9.1 Dicharge of Firearms By-Law

Monique Ouellet presents the proposed by-law.

Mr. Dan Ampleman, resident of Cheney and hunter, explains that Council needs all the required information in order to make a decision. He thanks the City for its close collaboration. He explains that some of these changes are not appropriate, in particular the discharge of firearms in trails which is enacted under the Federal Law. He adds that the small game hunting will be affected with the restricted zone for bows and crossbows.

Mayor Desjardins explains that a committee should be established in order to discuss the changes proposed within the Larose Forest with the United Counties of Prescott and Russell.

Mr. Mathieu Lafleur, resident at 270 Trilium in Wendover and owner of Pro-Nature, presents his petition against the adoption of the by-law. He adds that the individuals are in agreement with constructive modifications to the by-law.

Mrs. Tracey Wilson, Vice-President of the Canadian Coalition for firearms rights, explains that it is important to explore the opportunities to maintain the culture of hunting in the community families. She adds that hunting has a huge impact on the local economy.

Mr. Martin Lacasse, President of the Rockland Field Archers, suggests allowing the archery in arenas for tournaments. Mayor Desjardins explains that Mr. Lacasse needs to address his request to Mr. Pierre Boucher or Mr. Jean-Luc Jubinville.

Mr. Gérard Fortin, resident of 3422 Champlain Road, asks why the City regulates the Larose Forest when it belongs to the UCPR. Mrs. Ouellet explains that a portion of the forest is within the boundaries of the City of Clarence-Rockland. Mayor Desjardins adds that many cycling trails have been added by the UCPR in the current year and that they want to protect the users.

Mr. Rolland Labonté, 3713 Verdon Street, Plantagenet, asks for clarifications in regard to Pago Street. Mayor Desjardins explains that a portion of this area belongs to EQ Homes and many houses are in the area. Mr. Labonté explains that he does not want it to be developed like Ottawa does.

Mr. Dan Ampleman explains that a problem is that people who don't hunt are not informed; a huge problem of knowledge is in the community.

Councillor Mario Zanth asks for an update with regard to the fees charged for those who are accident victims. Mr. Wilson explains that he needs a clear directive in order to make changes. Mrs. Collier adds that this will be discussed during the budget process.

Councillor Mario Zanth explains that a business has been refused for the \$10,000 CIP grant because it was not in the core. Mrs. Collier and Mr. Darch take note of this.

Councillor Mario Zanth asks if the traffic lights could last longer for pedestrians between the Food Basics and the Rockland Manor. Mayor Desjardins asks him to send him an email and that he will follow-up with the UCPR in regards to this matter.

Councillor Jean-Marc Lalonde asks if it is possible to install traffic calming posts on St-Jacques on the north side of Laviolette to Patricia and on the south side of Laviolette to the curb to St-Denis.

Councillor Jean-Marc Lalonde mentions that there is 14 burned street lights, one located in front of Laporte. Mayor Desjardins asks for an update with regard to the street lights LED conversion project.

Councillor Jean-Marc Lalonde explains that the note prepared for the storm water master plan study is in English only.

Councillor Carl Grimard explains that the City has a problem with grass cutting management this year. Mr. Darch explains that he will verify.

Councillor Diane Choinière explains that there is a safety issue at the Portage, on the East and West side, in particular when people park their trailers.

Councillor Michel Levert explains that people drive fast on Joanisse Road. Mr. Wilson suggests installing temporary signs to ask them to slow down.
