# Sports Field Rental Policy

# **1.0 Policy Statement**

The City of Clarence-Rockland provides the community with sports fields to encourage residents to lead a healthy and active lifestyle.

# 2.0. Goal and Objective

The goal of this policy is to put forth a set of principles and guidelines which are required for rental management of sports fields under the responsibility of the City of Clarence-Rockland's Operations Services.

## **3.0 Definitions**

« Department », refers to the City of Clarence-Rockland's Operation Services.

« Seasonal permit holder », refers to a group who rents a municipal sports field on a regular and ongoing basis throughout a season.

« Casual permit holder », refers to a group who rents a municipal sports field on a sporadic and irregular basis.

« Special events », refers to any activity which is sporadic and falls outside of regular seasonal requests (ex. Tournament).

« Exceptional circumstances », means extreme weather conditions which make the sports fields unusable.

# 4.0 Scope

This policy applies to all municipal sports fields permit holders.

# 5.0 Procedures and Guidelines

## 5.1. Facilities

The Department is responsible for managing the following sports fields:

#### 5.2. Season

The sports fields season begins on May 15<sup>th</sup> and ends on October 15<sup>th</sup>. The Department reserves the right to modify these dates due to exceptional circumstances.

## 5.3. Rental Application

The rental application process for all sport fields is managed by the Department. Please note that Tennis courts and Pickle Ball courts are free of charge and can be utilize during hours of operation on a first come basis.

## 5.4. Allocation of Field Rental Time

## 5.4.1. Priority – Seasonal permit holders

For Seasonal permit holders, allocation for regular and special events will be allocated as follows:

- 1- City of Clarence-Rockland programming
- 2- Local youth sports associations
- 3- Local adult sports leagues (according to seniority)
- 4- Non-local youth sports associations
- 5- Non-local adult sports leagues
- 6- All other requests

## 5.4.2. Exceptions - Priorities

The Department reserves the right to change the order of priority described under paragraph 5.4.1. should they consider such changes essential to the effective management of the sports fields.

## 5.4.3. Priority – Casual permit holders

Priority for rental will be allocated on a "first come first serve" basis.

## 5.4.4. Sports field schedule

A one-hour rental period includes the time required to set up the field (ex. marking of field lines, installation of goals, installation of nets) and the time required to remove equipment from the field. Permit holders must respect their allocated time and use the field during the time of their reservation.

## 5.5. Refund, Return, and Cancelation

Other than for circumstances deemed exceptional by the Department, there will be no refunds, no returns, and no cancellations. In the event of inclement weather conditions, the Department allows permit holders to reschedule to a later date, at no extra cost.

5.5.1 Hours reserved for special events may be refunded as follows:

- Should the permit holder cancel their reservation at least 20 business days (4 weeks) prior to the scheduled activity, a full refund will be issued.
- Should the permit holder cancel their reservation 10 business days (2 weeks) prior to the

scheduled activity, a partial refund of 50% will be issued.

- Should the permit holder cancel their reservation less than 10 business days (2 weeks) prior to the scheduled activity, no refund will be issued.

Any reservation cancellations that do not fall within the categories mentioned above will not be refunded.

# 5.6. Cost of Repairs

The Department reserves the right to invoice the permit holder for the cost of any repairs needed due to excessive field use (ex. Use of field during heavy rainfall, use of field which is not compatible with normal usage, etc.)

# 5.7. Rental Fees

See permit holder fees and regulations for a complete list of all sports field rental rates.

## 5.7.2. Payment

#### Seasonal permit holder

Seasonal permit holders shall have 3 weeks following the start of the season to pay their invoice in full.

#### Casual permit holder

Prior to their rental date, casual permit holders will receive an invoice through the online portal. Payments must be received before the rental date. The Department reserves the right to cancel the rental if payment has not been made in time.

#### Late payment

Late payments shall be subject to applicable municipal policies. Late fees will apply with no exception.

#### Ongoing rates

Rental rates are in effect May 1<sup>st</sup> to November 1<sup>st</sup> of each year. Rates shall be reviewed during the municipal budgetary process.

5.8 Responsibilities City:

Baseball fields:	All field maintenance Provides Chalk powder and applicator.
Tennis courts:	All courts maintenance Provides nets
Soccer fields:	All field maintenance
Users: All field and courts:	Provides personal equipment (baseball gloves, bats, bases, soccer nets, balls ect) Line application

# 6.0 Liability Insurance

Prior to the rental period, the permit holder must obtain a \$2,000,000 liability insurance and the liability insurance certificate must designate the City of Clarence-Rockland as an additional insured on the policy.
