# 10.1 Delegations/Presentations

# a. Presentation by Michel Gratton and Joseph Gonsalves regarding concerning the supply of water to Labelle and Schnupp streets

Joseph Gonsalves explains that he filed a petition last year for the water supply, as the network is 0.6 km from his property. He adds that water quality tests on his property are poor, and he has even been referred to the Ministry of the Environment for follow-up. Joseph Gonsalves explains that his request is made on behalf of the residents of the area.

Further to questions, Jean-Luc Jubinville explains that a meeting has been held with Joseph Gonsalves and Michel Gratton regarding this request. He explains that the network is designed to avoid dead-ends, and connecting to the requested sector could create one. He adds that a network connection such as the one requested requires a substantial investment on the part of residents, as payment is not made by all taxpayers, but only by users.

Mayor Zanth explains that he will contact local representatives of the province to see what options are available to enable water supply to these locations.

# b. Presentation by Jean-Marc Lalonde for the installation of a monument in honour of Guy Lafleur at 2169 Laurier Street

Jean-Marc Lalonde presents his project. He explains that it would be important to find a place where people could stop and take photos and suggests 2169 Laurier Street as a location. He suggests inaugurating the project on October 1, close to Guy Lafleur's birthday.

Further to questions, Jean-Luc Jubinville explains that the proposed space is too small and that it is not recommended to install a monument in the road right-ofway.

Mayor Zanth explains that he will offer a contribution of \$5,000 from his UCPR budget and suggests that Council members offer the remainder from their discretionary budget.

WHEREAS a fundamental, underlying principle of broadening diversity, equity and inclusion in politics rests on the assumption that the workplace is safe; and

WHEREAS Bill 5, the Stopping Harassment and Abuse by Local Leaders Act would require Councillors to comply with the workplace violence and harassment policies of the municipality they represent, permit municipalities to direct the Integrity Commissioner to apply to the court to vacate a member's seat for failing to comply with the municipality's workplace violence and harassment polices as well as restrict officials whose seat has been vacated from seeking immediate subsequent re-election; and

WHEREAS over 40 municipalities have formally endorsed and communicated public support for Bill 5; and

WHEREAS Bill 5 would both hold accountable and protect all municipal officials;

BE IT RESOLVED that the Council of the City of Clarence-Rockland express its support for Bill 5, Stopping Harassment and Abuse by Local Leaders Act; and

BE IT FURTHER RESOLVED that this resolution be sent to the Hon. Doug Ford, Premier of Ontario, the Minister of Municipal Affairs and Housing, the Association of Municipalities of Ontario and Stéphane Sarrazin, MPP for Glengarry-Prescott-Russell.

WHEREAS there are no regulations requiring most IC&I to recycle; and

WHEREAS the Administration is concerned that if merchants are not required to recycle, all of their recyclable materials will end up in the waste collected by the City and taken to the municipal landfill; and

BE IT RESOLVED THAT Council mandates the administration to amend the garbage collection by-law to require ICI's who wish to obtain the garbage collection service offered by the municipality to provide proof of a collection contract for their recyclable material on an annual basis.
