

# Corporation of the City of Clarence-Rockland

## By-law 2024-17

Being a By-law to amend Zoning By-law No. 2016-10.

Whereas Zoning By-Law No. 2016-10 regulates the use of land, and the use and construction of buildings and structures in the City of Clarence-Rockland; and

Whereas the Council of the Corporation of the City of Clarence-Rockland considers appropriate to amend Zoning By-Law No. 2016-10, as described;

Therefore, the Council of the Corporation of the City of Clarence-Rockland enacts as follows:

1. The property described as 604 Caron Street, Part of Lot 29 on 1908 Andrew Bell Plan, former Town of Rockland, in the former geographic Township of Clarence, now in the City of Clarence-Rockland and identified on Schedule "A" attached to and forming part of this by-law shall be the lot affected by this by-law.
2. Map "B" of Zoning By-Law No. 2016-10 is hereby amended by changing the zoning category of the subject property from "Urban Residential First Density (R1) Zone" to "Urban Residential Second Density-Exception 34 (R2-34) Zone" as identified on Schedule "A" of the map attached hereto and fully integrated as part of this By-law.
3. Section 6.3.3 is hereby amended by adding the following subsection (hh) to read as follows:

(hh) R2-34, 604 Caron Street

Notwithstanding the provisions of this By-law to the contrary, the lands zoned R2-34 shall be used in accordance with the following provisions:

- (i) Minimum Front Yard setback: 4.3 m
  - (ii) Minimum Interior Side Yard setback: 2.5 m
  - (iii) semi-detached dwelling not required to have individual driveway and may be located on adjacent lot.
4. This By-law shall become effective on the date of passing hereof, subject to the approval of the Tribunal or following the last date for filing objections as the case may be.

## Explanatory Note

### Purpose and Effects of By-Law No. 2024-17

The purpose of the by-law is to amend Zoning By-Law No. 2016-10 in order to change the zoning category of the subject property from "Urban Residential First Density (R1) Zone" to "Urban Residential Second Density-Exception 34 (R2-34) Zone" in order to allow the construction of a semi-detached dwelling on a single lot.
