CORPORATION OF THE CITY OF CLARENCE-ROCKLAND

BY-LAW 2019-63

BEING A BY-LAW TO PROVIDE THAT SUB-SECTION 5 OF SECTION 50 OF THE PLANNING ACT, R.S.O. 1990, CHAPTER P.13, AS AMENDED, DOES NOT APPLY TO PART OF BLOCK A, REGISTERED PLAN 39, PART OF LOT 24, CONCESSION 1 (O.S.), IN THE CITY OF CLARENCE-ROCKLAND, IN THE COUNTY OF RUSSELL, DESIGNATED AS PART 1 TO 6 ON PLAN 50R-9748.

WHEREAS Sub-Section 5 of Section 50 of the *Planning Act,* R.S.O. 1990, Chapter P.13, as amended, provides that all lands within a Plan of Subdivision are subject to part-lot control; and

WHEREAS the Council of a municipality may, under Sub-Section 7 of Section 50 of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, enact a by-law to provide that Sub-Section 5 of Section 50 of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, does not apply to such lands as are designated in the by-law; and

WHEREAS a semi-detached was built on Part of Block A of Registered Plan 39, Part of Lot 24, Concession 1 (O.S.) where it is desired that individual ownerships be created and designated as Parts 1, 2 and 3 and Parts 4, 5 and 6 on Plan 50R-9748.

NOW THEREFORE the Council of the Corporation of the City of Clarence-Rockland enacts as follows:

- 1. **THAT** subject to section 3 hereof, Sub-Section 5 of Section 50 of the *Planning Act,* R.S.O. 1990, Chapter P.13, as amended, does not apply to the following lands:
 - a) Part of P.I.N. 69079-0023, being those portions of Block A, Registered Plan 39, Part of Lot 24, Concession 1 (O.S.), designated as Parts 1, 2 and 3 on Plan 50R-9748 and further designated as Parcel 'A' for the purpose of this by-law;
 - b) Part of P.I.N. 69079-0023, being those portions of Block A, Registered Plan 39, Part of Lot 24, Concession 1 (O.S.), designated as Parts 4, 5 and 6 on Plan 50R-9748 and further designated as Parcel 'B' for the purpose of this by-law;
 - all in the City of Clarence-Rockland, in the County of Russell and registered in the Land Titles Office for the Land Titles Division of Russell (No. 50).
- 2. **THAT** this By-law shall take effect upon approval thereof by the Council of the Corporation of the City of Clarence-Rockland and in compliance with the requirements of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended.
- 3. This By-law shall expire and be of no further force and effect, if not registered on title, as of the 17th day of June, 2021.
